1. CATEGORIES OF PERSONAL DATA SUBJECT TO PROCESSING | DEFINITIONS

The personal data provided – or otherwise acquired in accordance with applicable legal provisions – related to, connected with, and/or necessary for your browsing experience on our website will be processed in accordance with the Federal Act on Data Protection (FADP) and in compliance with confidentiality obligations.

Personal data: any information relating to an identified or identifiable person.

In particular, we will process the following categories of personal data:

- Data voluntarily provided by the user (such as name and email address, via the contact form in the “Contact” section of this website).

Data subjects: natural persons whose data are being processed (hereinafter also referred to as the “user”).

Processing: any operation involving personal data, regardless of the means and procedures used, including, in particular, the collection, storage, use, review, disclosure, archiving, or destruction of data.

Disclosure: making personal data accessible, for example by allowing access, transmission, or publication.

4. RECIPIENTS OF PERSONAL DATA

5. TRANSFER OF PERSONAL DATA OUTSIDE THE CONFEDERATION

6. DATA SUBJECT'S RIGHTS

Pursuant to the Swiss Federal Act on Data Protection (FADP/LPD), the Data Controller recognizes that you, as the data subject, have the following rights (this list is not exhaustive):

- To obtain the rectification of inaccurate or outdated personal data;
- To be informed in writing and free of charge if personal data concerning you are being processed;
- To prevent the disclosure of any sensitive personal data to third parties;
- To obtain data portability or request that personal data be transferred to third parties;
- To request the restriction or blocking of data processing, the prevention of disclosure of data to third parties, or the rectification or destruction of personal data;
- To request the prohibition of specific data processing or disclosure to third parties, or the deletion or destruction of certain personal data;
- If neither the accuracy nor inaccuracy of personal data can be proven, to request the addition of a note indicating the dispute;
- To request that rectification, destruction, blocking (especially of disclosure to third parties), as well as the note on the dispute or court ruling, be communicated to third parties or published;
- To declare the illegitimacy of the processing of personal data.

Without prejudice to any other administrative or judicial remedy, if you believe that the processing of your personal data violates the provisions of the FADP, you have the right to lodge a complaint with the competent supervisory authority (Federal Data Protection and Information Commissioner - FDPIC).
